• Comments

When visitors leave comments on the site, we collect the data displayed on the comment form, as well as the visitor’s IP address and the browser’s string of user agents to help detect spam.

An anonymous string created from your email address (also called a hash) can be provided to the Gravatar service to see if you are using it. The Gravatar service privacy policy is available here: <https://automattic.com/privacy/>. After approval of your comment, your profile image is visible to the public in the context of your comment.

• Contact Forms

Most of our services do not require any kind of registration, which will allow you to visit our website without leaving any data behind. However, some of the services will ask you to provide your personal data. In these situations, if you choose not to provide us with the personal data requested, you may not have access to some sections of the website or we may not be able to respond to your query.

All personal data collected through this website will be included in a file owned by HINODE, in order to provide the products or services you have requested, as well as to keep you informed, including by electronic means, about HINODE products and services that we believe may be of interest to you. In any case, the use of your data for any other purpose will be communicated at the time of collection.

Types of cookies

- Own cookies: Are those sent to the user's terminal equipment from a computer or domain managed by the editor himself and from which the service requested by the user is provided.
- Third-party cookies: Cookies are sent to the user's terminal equipment from a computer or domain that is not managed by the publisher, but by another entity that processes the data obtained through cookies.
- Session cookies: Are a type of cookies designed to collect and store data while the user accesses a website.
- Persistent cookies: They are a type of cookies in which the data is still stored in the terminal and can be accessed and treated during a period defined by the person responsible for the cookie, which can go from a few minutes to several years.
- Analysis Cookies: These are those that are treated by us or by third parties and allow us to quantify the number of users and thus carry out the measurement and statistical analysis of the use made by the users of the service offered. For this purpose, your navigation on our website is analysed in order to improve the products or services we offer you.
- Advertising cookies: These are those that allow the management, in the most efficient way possible, of the advertising spaces that, in their case, the publisher has included in a web page, application or platform from which it provides the requested service based on criteria such as the edited content or the frequency in which the advertisements are shown.
- Behavioral advertising cookies: These are those that allow the management, in the most efficient way possible, of the advertising spaces that, in their case, the publisher has included in a web page, application or platform from which it provides the requested service. These cookies store information on user behavior obtained through continuous observation of their browsing habits, which allows the development of a specific profile to display advertising based on it. It is also possible that when you visit a web page or open an email where an advertisement or promotion about our products or services is published, a cookie is installed in your browser that serves to show you later advertising related to the search you have made, to develop a control of our ads in relation, for example, to the number of times they are seen, where they appear, what time they are seen, etc.

Types of cookies used by this website

The cookies used in our website are session and third party cookies, and allow us to store and access information regarding the language, the type of browser used, and other general characteristics predefined by the user, as well as, follow and analyze the activity carried out, with the aim of introducing improvements and providing our services in a more efficient and personalized manner.

How long we keep your information
